He earned both his law degree and his Ph. D. from Louisiana State University. Nathan is a former school board attorney who teaches masters and doctoral courses in school law, organizing the learning environment and legal liability in tourism, sports and recreation. His research focuses on legal issues that affect educational leaders. He served as the chair of the educational leadership program redesign for the college. He serves as a member of the Board and Treasurer of the National SAMs Innovation Project and as a TimeTrack coach for the NSIP.
	Since 2009, Nathan has co-edited 3 books and written numerous book chapters and refereed journal articles and also conducted numerous national, regional and local presentations. In July, 2014, he co-planned and presented a Higher Education Leadership Conference in Uganda for East Africa Higher Education leaders.
